Chapter VI SAFEGUARDING INTANGIBLE CULTURAL HERITAGE AND SUSTAINABLE DEVELOPMENT AT THE NATIONAL LEVEL

- 170. With a view to effectively implementing the Convention, States Parties shall endeavour, by all appropriate means, to recognize the importance and strengthen the role of intangible cultural heritage as a driver and guarantee of sustainable development, as well as fully integrate the safeguarding of intangible cultural heritage into their development plans, policies and programmes at all levels. While recognizing the interdependence between the safeguarding of intangible cultural heritage and sustainable development, States Parties shall strive to maintain a balance between the three dimensions of sustainable development (the economic, social and environmental), as well as their interdependence with peace and security, in their safeguarding efforts and shall to this end facilitate cooperation with relevant experts, cultural brokers and mediators through a participatory approach. States Parties shall acknowledge the dynamic nature of intangible cultural heritage in both urban and rural contexts and shall direct their safeguarding efforts solely on such intangible cultural heritage that is compatible with existing international human rights instruments, as well as with the requirements of mutual respect among communities, groups and individuals, and of sustainable development.
- 171. Insofar as their development plans, policies and programmes involve intangible cultural heritage or may potentially affect its viability. States Parties shall

- VI.2.3 Impact of tourism on the safeguarding of intangible cultural heritage and vice versa
 - 187. States Parties shall endeavour to ensure that any activities related to tourism, whether undertaken by the States or by public or private bodies, demonstrate all due respect to safeguarding the intangible cultural heritage present in their territories and to the rights, aspirations and wishes of the communities, groups and individuals concerned therewith. To that end, States Parties are encouraged to:
 - (a) assess, both in general and in specific terms, the potential of intangible cultural heritage for sustainable tourism and the impact of tourism on the intangible cultural heritage and sustainable development of the communities, groups and individuals concerned, with particular attention to anticipating potential impact before activities are initiated;
 - (b) adopt appropriate legal, technical, administrative and financial measures to:
 - b.i. ensure that communities, groups and individuals concerned are the primary beneficiaries of any tourism associated with their own intangible cultural heritage while promoting their lead role in managing such tourism;
 - b.ii. ensure that the viability, social functions and cultural meanings of that heritage are in no way diminished or threatened by such tourism;
 - b.iii. guide the interventions of those involved in the tourism industry and the behaviour of those who participate in it as tourists.

The UNESCO Cultural Conventions: a tool for sustainable development

All seven of UNESCO's Cultural Conventions are intended to safeguard and nurture some aspect of culture and creativity, from tangible and intangible heritage, the diversity of cultural expressions and creative industries, to the fight against the illicit trafficking of cultural goods.

While some have a development agenda more explicitly built into them than others, all of the Conventions have implications for development both in terms of how they can contribute to it and in the impact that development has on culture.

Firmly grounded in a human-rights based approach, these Conventions establish a range of governmental and international funding and cooperation mechanisms, as well as monitoring and evaluation tools. They promote capacity building programmes and other initiatives for the safeguard of culture (including natural heritage) and its integration in national and local development strategies.

Examples of how the Conventions contribute to development include the UNESCO designated sites, such as the nearly 1000 World Heritage properties and over 500 Biosphere Reserves, which provide ideal laboratories where innovative heritage-driven approaches to sustainable development are tested. Under the International Fund for Cultural Diversity (IFCD), established in the framework of the UNESCO 2005 Convention on the Protection and Promotion of the Diversity of Cultural Expressions, support is provided on a regular basis to developing countries, including nongovernmental organisations, for projects in the fields of cultural policies and cultural industries. EU-funded technical assistance missions, carried out within the framework of the same Convention, promote social and economic development, in particular to strengthen the system of governance of the culture sector.

Integration of Culture in Sustainable Development

Approved by the Conference of Parties at its second session (June 2009)

General considerations

- Sustainable development is "development that meets the needs of the present without compromising the ability of future generations to meet their own needs" (Report of the World Commission on Environment and Development, 1987).
- 2. The economic, cultural, social and environmental aspects of sustainable development are complementary.
- 3. Protection, promotion and maintenance of cultural diversity are essential requirements for sustainable development for the benefit of present and future generations (Article 2.6 of the Convention), since they contribute to social and cultural fulfilment, individual and collective well-being, and to the maintenance of creativity and vitality of cultures and institutions.

- 5. Culture should be integrated into national policies and plans and into international cooperation strategies in order to achieve human development goals¹ and notably poverty reduction.
- 6. The integration of culture into development policies at all levels (local, national, regional and international) makes it possible to:
 - contribute to the protection and promotion of the diversity of cultural expressions; 6.1
 - foster universal access, participation in and enjoyment of creation and production 6.2 of cultural expressions, especially for disadvantaged groups;
 - 6.3 realize the full potential and contribution of cultural industries to sustainable development, economic growth and the promotion of decent quality of life through the creation, production, distribution and dissemination of cultural expressions;
 - 6.4 maintain social cohesion, fight violence through cultural activities that promote human rights and the culture of peace and reinforce the sense of social integration of youth;

Guidelines

- 7. Sustainable development is the result of a collection of policies and measures suited to national and local contexts that maintain the harmony of the local cultural ecosystem. For the sake of ownership and harmonization of development policies, when developing such policies, Parties shall endeavour to take into account the following elements.
 - 7.1 Since economic, environmental, social and cultural systems are interdependent and cannot be considered separately, sustainable development policies and measures should be formulated, adopted and implemented in concert with all the relevant public authorities in all sectors and at all levels. Thus effective coordination mechanisms should be established, particularly at the national level.
 - 7.2 Raising awareness among decision makers and their partners of the importance of the cultural dimension of development policies and sensitizing development policy managers from other sectors to cultural issues are essential for achieving the objectives of Article 13.
 - 7.3 The integration of culture into sustainable development policies entails acknowledgment, in particular, of:

7.3.1 the fundamental role of education for sustainable development and the inclusion of culture in the different aspects of educational delivery to foster an understanding and appreciation of diversity and its expressions;
